In the opening session Dr C. Subbakrishna given presentation on NATCOM /SCALE 2017 to be held on 16th and 17th November 2017 at Vivanta by Taj M.G. Road, Bangalore. He also made an appeal to all the delegates from organization for attending NATCOM and get domain knowledge from the technical conference.

Mr. H.R. Gowri Shankar, Tax Consultant and Advocate addressed and gave presentation on the GST implementation in industries, and explained the applicability of GST Law. He spoke, that the GST is a single tax on the supply of Goods and / or services, right from the Manufacturer to the Consumer, levied by both i.e. the Centre & the respective State Governments., simultaneously on each transaction. Keeping in mind the Federal structure of India, basically there will be Two components of Taxation under the GST law i.e. Central GST (CGST) & State GST (SGST). Thus, both Centre/ State(s) shall levy GST across the value chain simultaneously. He also explained that Utilization of Input Tax credits (ITC), SGST, IGST and Category of person(s) required to be Registered. He very nicely briefed about the GST how it will Challenges to Trade & Industry.
