## **Education Updates - White Paper**

- 1. **AICTE Approval** AICTE Approval for the academic year 2020-21 is under process, necessary application form and payment have already been made to AICTE. Notification for new admission in respect of PGDMM and PGDSCM&L for July-Dec 2020 session, willbe hosted on the website. After Scrutiny of Documents and issue of Extension of Approval letter.
- **2. Admission (Jan Jun 2020)** Admissionprocess for PGDMM and PGDSCM&L Programs are still on and notification/circular for the same has been issued by IIMM NHQs. Admission dates have now been extended till 30<sup>th</sup> April 2020. However, confirmation of the admission will be made only after the ongoing lockdown is over.
- 3. **Reading Material** Most of the course material have already been dispatched to students and branches. Few packets are lying packed at IIMM Delhi office, which could not be dispatched due to lockdown as both postal and courier services were not available. However, soft copies of the books are available on IIMM Website i.e. <a href="www.iimm.org">www.iimm.org</a> under Ebooks-----Student Zone -----Education TAB. - 4. **Assignments** Due to the current covid 19 scenario, IIMM has decided to take assignments in two modes
  - a. **Theory based** Assignments as already uploaded on the IIMM website.
  - b. **MCQ based** Assignments based on MCQs, will be uploaded on the IIMM website shortly.

Studentswho have completed theory based assignments, can send scan copy of the assignments to IIMM NHQs through email and they need not to submit MCQs based assignment. However, who wish to submit MCQ based assignments can do so and submit the answered copies to IIMM NHQs through Email or Whatsapp. The last date of submission of Assignments have now been extended till 15th May 2020.

- **5. Contact Classes** Contact Classes are one of the mandatory requirements for ODL Institutions (as per APH 2020-21, AICTE). However, due to the ongoing Pandemic crisis of Corona Virus, these physical classes are not possible. I am pleased to apprise you that, IIMM have started Online Contact classes through "Google Hangouts Meet", a significant step in this direction, to meet the AICTE Guidelines and extending its support to students at National Level. One such online contact classtook place on 15<sup>th</sup> April 2020. Schedule for next Online Contact class will be intimated shortly through Email and link of the Contact Class will also be provided on IIMM Website.
- 6. **Examination results** Results for December 2019 examination have already been declared and uploaded on IIMM Website, which can be accessed by the students by putting in their roll nos. Results for 3<sup>rd</sup> Semester Examination, held in March 2020, will be announced shortly after the lockdown period is over.

- 7. **Examination Schedule** Examination to be held in June 2020 will be scheduled as per the Govt. Guidelines and Policy for conducting Examinations in view of the Nationwide lockdown.
- 8. **Academic and Administrative activities** All Universities/Institutions have delayed their activities due to the ongoing Corona Virus Pandemic. We will follow the revised guidelines likely to be issued by AICTE for Standalone Institutions.
- 9. **Govt. Committee for Education Activities** Govt. of India, has set up a committee to review the Education Activities particularly the Admission and Examination Schedule. They will submit their recommendations to the Govt. at the earliest and based on which, we will circulate the Admission and Examination Schedule to the students. We are in constant touch with AICTE Authorities to guide on these issues and anything significant will be circulated to all the Branches.
