In pursuance of the Memorandum of Understanding (MoU) signed between the **Indian Institute of Coal Management (IICM), Ranchi** and the **Indian Institute of Materials Management (IIMM)** on **22 December 2025**, it is hereby notified that the **Advance Professional Diploma in Contract Management (APDCM)** shall be conducted for eligible executives of **Coal India Limited**.

The programme is designed to enhance professional competence in **public procurement and contract management**, with emphasis on statutory provisions, contract lifecycle management, risk mitigation, dispute resolution, and contemporary industry practices.

Programme Details

- **Name of the Programme:** Advance Professional Diploma in Contract Management
- **Duration:** Six (06) Months
- **Mode of Delivery:** Blended Mode

Eligibility Criteria

- Executives of **Coal India Limited** in **E-4 grade and above**
- Possession of a **Bachelor's Degree in any discipline**

Batch Size & Selection Procedure

- **Maximum batch size:** 80 participants
- Selection through an **online screening test conducted by IIMM**
- **Minimum qualifying marks:** 80 percentile
- In case of a tie, **higher length of experience (in months)** shall be considered
- The screening test shall comprise **general objective-type questions related to public procurement and contract management guidelines**

Registration Process

- Registration for the programme shall be done **online only** through the registration link provided:

- A **QR Code** has also been provided in the notification for ease of access.
- No offline or manual applications shall be entertained.
- Registration can be completed upon payment of a registration fee of **₹ 300/-**.

Course Fee & Payment

- **Course Fee:** ₹15,000/- (Rupees Fifteen Thousand only) per participant
- **Payment of course fee shall be required only from candidates who are selected** through the screening process.
- The selected candidates shall pay the course fee **directly to IIMM through online transfer.**
- **Payment details shall be communicated separately to the selected candidates.**
- The fee is **non-refundable.**

Certification

Participants fulfilling the prescribed **attendance and evaluation criteria** shall be awarded the **Advance Professional Diploma in Contract Management** by IIMM.

Faculty, Evaluation & Examination

- Faculty/resource persons shall be provided by **both IICM and IIMM**
- Term-end examination and evaluation shall be conducted by **IIMM at IICM, Ranchi**
- Results, mark sheets, and certificates shall be issued by **IIMM**
